4. FIRST AID MEASURES

Description of necessary measures

Inhalation: First aid measures not required.
Skin contact: First aid measures not required. Cosmetic product and therefore not necessary.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation. After inhalation: Unlikely to occur due to the physical properties of the product. At elevated temperatures, vapors or mists may cause irritation. 6. ACCIDENTAL RELEASE MEASURES
