### 4. FIRST AID MEASURES

#### Description of necessary measures

**Inhalation:** Move to fresh air. If symptoms persist, seek medical advice.  
**Skin contact:** Rinse affected area with large amounts of mild soap and water until no evidence of product remains. If adverse health effects develop seek medical attention.

#### Most important symptoms and effects, both acute and delayed
