4. FIRST AID MEASURES

Description of necessary measures

Inhalation:	First aid measures not required.
Skin contact:	First aid measures not required. Cosmetic product and therefore not necessary.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation, with possibility of corneal injury if not removed promptly. After skin contact: Repeated or prolonged excessive exposure may cause irritation or sensitization dermatitis in previously exposed individuals. After Ingestion: Ingestion may cause pain, burning, swelling and redness in the mouth and throat. Nausea and vomiting may occur.
