### 5. FIREFIGHTING MEASURES

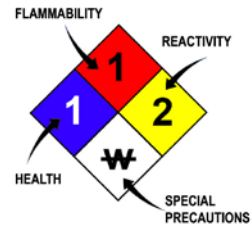
